Question (a) whether it is a fact that although public sector banks, private banks, and insurance companies are not obligated under the Companies Act 2013 to engage in CSR, they still undertake social initiatives in accordance with RBI guidelines and the policies of their respective boards.

GIC Re Response (a) Under Section 135 of the Companies Act, 2013, companies meeting the prescribed financial thresholds—Net Worth of ₹500 crore or more, Turnover of ₹1,000 crore or more, or Net Profit of ₹5 crore or more—are mandated to undertake Corporate Social Responsibility (CSR) activities. GIC Re falls within these criteria and is therefore obliged to comply with the CSR provisions of the Act. In accordance with this statutory requirement, GIC Re has adopted a Board-approved CSR Policy and allocates the prescribed percentage of its profits towards CSR initiatives. These initiatives are aligned with the activities listed under Schedule VII of the Companies Act, focusing on areas such as education, healthcare, rural/Infra development, and environmental sustainability. Our approach ensures that CSR is not merely voluntary but a legal and ethical responsibility integral to our corporate governance framework.

Question (b) if so, whether there is a policy to ensure regional balance so that backward states like Bihar could receive adequate benefits

GIC Re Response (b) GIC Re's CSR Policy, approved by its Board, emphasizes inclusive development and prioritizes projects that create measurable social impact. In compliance with the Companies Act, 2013, we allocate CSR funds across PAN India, focusing on areas where the need is greatest. While there is no statutory mandate for regional allocation, our policy framework encourages equitable distribution of CSR activities across geographies, including aspirational and backward districts. We actively consider proposals from states like Bihar under our thrust areas—education, health, rural infrastructure, and skill development—to ensure balanced outreach. Additionally, we align our efforts with government priorities and guidelines to bridge regional disparities and maximize social impact.
